- bulk water used by BNSF over the past couple of weeks was 113,900 gallons
- Lindsey Tope brought to the Town office material she believed had come into her the rental trailer house she owns on the west side of town from the town water system. Willie will contact her and discuss the situation.
- Mayor Benner relayed the details and showed photos of an incident earlier in the day between Jimmy Wang and the Bidwell property. Snow had been removed from the Bidwell driveway and pushed onto town right of way along the fence of the property Jim leases from V & R Farms. Jim then moved the snow and piled in on Town right of way and the Bidwell's yard. A letter will be sent to Mr Wang asking that no snow be placed on private property in the future.

**Old Business**

- Snow removal – the snow plow has been working well. The clerk will send a reminder to Town residents to move vehicles off the street in the case of a snow event.

**New Business**

- The sewer at the VoAg building is blocked.
- MDU will be replacing the current street lights with LED lights. The cost of the rental for each light will increase but the power usage will decrease resulting in a lower to equal cost overall. A motion was made by Seth, seconded by Kyle to accept the contract with MDU for the LED improvements.
