Approve May 9, 2016 Regular Meeting Minutes

The minutes of the May 9, 2016 Regular Meeting were read and approved.

Auditor's Report - Jim Wosepka

- Due to the severe weather today Jim was not able to be at the meeting but instructed the Clerk to let the Council know he would be happy to come to the next meeting or answer any questions by phone.
- The Council reviewed the Audit Report and approved as presented.

Correspondence

- Brenda with the Fallon County Clerk and Recorder left a message alerting the Town that the County does not carry insurance on the park improvements. The clerk contacted Jim Leischner with the Insurance Store and he has now bonded the park shelters, bathroom and playground.
- The City of Baker sent notice that the charge for mosquito control remains unchanged at \$90.00 per hour. Motion was made by Gary, seconded by Shawn to pay this amount to the City of Baker, all in favor, motion carried.
- Greg Hauff has turned in a building permit for a 40x40 pole barn to be built on his property located at 131 1st
 St. The permit was reviewed and a motion was made by T.C., seconded by Shawn to accept the permit as presented. All in favor, motion carried.

Old Business

Zoning Ordinance - Mary Grube, Planner Administrative Assistant

- Subdivision fees need to considered, it has been determined that the current rates will not offset expenses
 and leave the town with a balance owing the Planner.
- There is a zoning regulation grant available through CDBG that is due the end of June. The matching amount is \$18,000. Mary will talk to the Baker City Council about splitting the match amount and also using Forrest Sanderson to update their zoning ordinances. A motion was made by TC and seconded by Shawn to apply for the zoning regulation grant and to request a 60/40, Baker/Plevna split of the matching funds.

- Mary asked for clarification on the where the Krikorians' would be hooking onto Town water. They will be installing a pit along Hwy 12 above the old pool and tapping into the main there.
- There will be a public hearing for the Growth Policy in August.

Water Project

- Kinkaid was here and did some temporary warranty work, they stated they will be back in a couple of months to continue.
- Both curb stops at the Lutheran Church are to crooked to get a key on. Cliff straightened both of them and installed stationary rods.

Letter of Concern

- Discussion was held about the many crooked curb boxed Kinkaid installed during Phase 2. Ryan Rittal with Stahly Engineering told Willie it was fine that they were crooked as long as a key can get on.
- When Kinkaid seeded the disturbed areas no top soil was brought in.
- Will Stahly be here to oversee the warranty work and will that be an added expense for the town the clerk will contact Stahly to find out.

- Willie would like to the household garbage that accumulates around residences addressed in the Nuisance ordinance.
- No survey markers were put in on the Vennes property at the east end of Railroad Ave, the clerk will contact Stahly Engineering to find out why.
- The tenants in the hotel on Main Street have been burning garbage, the clerk will contact them.
- There is Canadian thistle at the pool and at the dump site. The clerk will contact the Fallon County Weed Department for a rate schedule.
- The tenants at the Lindsey Tope rental have been blocking the alley with vehicles. T.C. spoke with them about the issue.
- Willie put the street signs back up that were vandalized on April 9, 2016. A claim will be turned into the Fallon County Sheriff for four hours of his time at \$25.00 an hour.

- There needs to be a culvert installed in alley for both the 1st Baptist Church and the Catholic Church.
- Mellon's are planning to replace the trailer house to the south of their auto repair shop. The hydrant will be taken out at that time.
