- **Seth Wiseman – Oath of Office**

- **Resignation of Council Member**

Connie Alberts has resigned from the position as Councilmember that was acclaimed in November. A replacement will be appointed at the December meeting to begin service in January.

**Mary Grube – Planning Board update**

The Fallon County Planning Board has reviewed and voted to accept the Subdivision Regulation changes required by the State of Montana. The Town of Plevna will need to hold a Public Hearing which will take place in December. Mary will publish the needed notices in the Fallon County Times.

**Department Reports**

Water – Rick Schell: still no gallons submitted from MP or Southeast for the Midrivers Fiber project, when the gallons are presented the water loss issue will be further evaluated.

Sewer – Corrine Sanders: absent

Garbage – Mark Thielen: MP has been cooperative about closing the gates at the dump site which has cut down on unauthorized dumping of garbage.


