Water Project

Planning Department Updates - Mary Grube, Planner Administrative Assistant

- The Grant was awarded in the amount of \$25,000.00 instead of the requested \$50,000.00. Baker is going to opt out of the project. The matching funds for the Town of Plevna should be around \$9,000.00.
- Mary will publish the Request for Proposals (RFP), to procure a professional planner/consultant to complete the initial zoning regulations. The RFP will run for three weeks.

Department Reports

- **Water** – DEQ inspected the school and could not find any reason for the positive test. They recommended Rick go back to his regular schedule of testing. Rick will flush the hydrant by the school before he tests there again in January.
